Urgent – We need your help!

We need to keep your children safe! We have witnessed too many near-misses of accidents during drop off in the morning and pick up at the end of the day. Our patrols and staff members are trying to keep pedestrians safe, but the number of vehicles not obeying traffic signs makes it a very risky job. Patrols cannot see oncoming traffic when there are vehicles waiting in the no stopping zones. Our School Resource Officers through the Winnipeg Police Department have witnessed the same.

You can help!

- **Obey the traffic signs** including NO stopping zones and NO parking zones. Please allow time to park in an appropriate spot on a street and walk your younger child(ren) to the school.
- Our neighbours need to access their driveways at all times. Please **DO NOT block driveways**.
- If you have older children (grades 3 and up), please consider arranging with your child(ren) for drop-off and pick up away from the school. Many side streets have safe routes to walk a block or two to get to school and it would reduce the amount of traffic during those busy times.
- Our parking lot is for staff only from early morning into the evening.

 The drive-up lane between the school and parking lot should be used for day care drop off ONLY.





Community Volunteer Income Tax Program (CVITP)

The CVITP is

A collaboration between the Canada Revenue Agency (CRA) and community organizations. The community organizations host free tax preparation clinics and arrange for volunteers to prepare income tax and benefit returns for eligible individuals who have a modest income and a simple tax situation.



Be Sure To Bring The Following:

- 1. Valid government photo id
- 2. T4, copy of last payroll
- 3. T4e, t5007 statement of employment insurance and other benefits
- 4. RC62 (universal childcare benefit statement)
- 6. Childcare Benefits and expenses
- 7. RRSP contributions
- 8. Medical receipts
- 9. Rent assist documents (receipts)

Family Income Eligibility

One Person \$40,000

Couple \$50,000

One Adult with Child \$45,000

You Are Not Eligible If You

- *Are Self Employed *Have Rental Income
- * Are Filing For a Deceased Person
- * Have More Than \$100,000 Foreign Property
- *Have more Than \$1000 Interest Income

Contactless Drop-off form for the Community Volunteer Income Tax Program (CVITP)

Please fill out ONE (1) Sheet per Adult in your household who are getting their taxes done. Married or Common-Law couples MUST get their taxes done at the same time. If you have children, the person who receives the Canada Child Benefit must include them on their form.

Please Include any slips you may have received, Receipts for Rent, medical expenses or childcare or if you own, your property taxes for the tax year.

We will be able to get any slips that have been sent to the CRA but will only file with the information we have been given. You must include everything for an accurate tax filing.

Taxes can be filed from 2014 – 2023. Please indicate if prior years are required.

WE CANNOT FILE IF:

You were self employed

Had rental income

Had Capital Gains

Filed for Bankruptcy in 2024

The person passed away in the year to be filed

PLEASE NOTE: TAX DOCUMENTS ARE PICKED UP AND DONE WITHIN A WEEK OF DROP OFF AND WILL BE RETURNED TO THE DROP OFF LOCATION. YOU MUST PICK THE DOCUMENTS UP

WITHIN 2 WEEKS OTHERWISE THEY WILL BE DESTROYED. TAX SLIPS CAN BE FOUND ONLINE WITH THE CRA OR BY CALLING 1 800 959 8281.

The Volunteers are able to get your slips directly from the CRA using Auto-fill my return. Any slip given to you that is reported to the CRA (T4, T4E, CPP, OAS. etc) will be pulled. This includes investment documents, however these can take longer to appear (Usually Late March, Early April) We will return all documents back to the 1050 Leila the Monday of the week after you drop them. It is your responsibility to pick them up. If you do not wish to leave your slips, please indicate this on the form. Otherwise, you must collect them within 2 weeks.
